
SAFETY REQUIREMENTS



- **U** DO NOT use the device at a high volume level for a long time. To avoid hearing loss, use the device at a comfortable volume level
- **u** Turn down the volume of the device before you put the headset on and then gradually turn it up until you reach a comfortable level
- Understand the laws and standards concerning the use of mobile phones and headsets when making phone calls while driving. Use caution when operating the device while driving a vehicle or performing any other attention-intensive activity. Adjust the volume so you can hear sounds around you, including sirens
- **µ** DO NOT use the device if the connected headset makes loud, unusual noises. If this happens, turn off the device and contact technical support
- **U** DO NOT expose the device to water and do not wear it while engaging in water sports, such as swimming, waterskiing, surfing, etc.
- Remove the headset immediately and turn off the device if you feel heat or sound quality deteriorates
- UDO NOT connect the USB Type-C cable in order to charge the device in public places or in public transport as this may cause damage to the device due to overheating
- The device contains small parts that may present a respiratory hazard
- DO NOT let children under 3 years of age use the device
- The device contains a magnet. Please consult a medical professional if you have any questions about the effects of a magnet on the medical devices you use or have implanted
- DO NOT disassemble the device or the headset
- **u** Use the device only with a power supply that complies with local regulations (e.g., UL, CSA, VDE, CCC)
- **µ** DO NOT leave the device where it will be exposed to heat, such as in direct sunlight, near a fire, etc.
- **µ** DO NOT use a microwave oven or other heating devices to dry the unit. Dropping the device on a hard surface may damage it
- During CT scans, X-rays, magnetic resonance imaging examinations, the device should be left outside the examination room
- UDO NOT use the device in areas where the use of electronic equipment is prohibited
- If used and maintained correctly, the device will serve you for a long time
- NOTE: if persons experiencing hearing loss are advised to consult a physician





DEVICE INFORMATION

This device is not a hearing aid. Like a magnifying glass, it helps expand the limits of human perception. The device can be used with 2 types of manufacturer-made ear-ins and these are included in the package. The device enhances the natural range of human hearing, but over-amplification can cause discomfort or damage your hearing if the device is not operated with safety requirements in mind. It is strongly recommended that you carefully read this user manual and other information from the manufacturer prior to use.









USING THE DEVICE





Unpack the device and take it out of the box.

Choose and attach the type of ear-ins that fit you better.

Plug the standard headset* (9) into Mini-jack 3.5" connector (2).

Insert the ear-ins** in your ears one by one



Push the round button (4) on the device's body. When it is switching on, you will see the light indicator (white) display current charge level

STEP 3. ADJUSTMENT OF THE DEVICE

Use a detachable wrench in the bottom of the device body (8) to adjust device settings by turning the screws (7) (follow the markings on the tear-off sticker when adjusting)



Settings are controlled by the adjustable screws on the device main body (assigned numbers 1 through 5 from top to bottom) and are described on the tear-off sticker (after the adjustment is complete, the tear-off sticker can be removed):

Good regular care will help the HEAR MOON headset to work longer. Use special care products for the ear-ins:

Alcohol-free cleaning wipes recommended by the manufacturers of cleaning wipes for ear plugs

Cleaning spray recommended by the manufacturers of care sprays for ear plugs and ear-ins. Take the ear-ins out, spray them and leave for 1-1.5 minutes:

- wipe them with a clean moisture-absorbing cloth and put them in their storage place once they fully dry
- ψ do not use ear-ins if they are dirty as it may lead to bacteria growth and inflammation
- **ψ** when used for a long time, ear-ins may lose its elasticity, which may result in parasitic acoustic feedback and other acoustic disturbances as well as ear inflammation





The device sounds quieter than usual or there is no sound:

- u check the level of the encoder
- u clean the sound ducts of the ear-ins from ear wax or replace them with new ones

There is parasitic acoustic feedback in the form of whistling and humming that lasts more than 5 seconds:

- reduce the amplification by rotating the encoder
- u check the fitting and depth of the position of your ear-ins
- up check if there is enough space between the device body and the speakers of the headphones

The battery gets low too fast (< 4 h):

- □ Turn screw □ clockwise until you can perceive the sound more clearly and intelligibly
- □ Turn screw (2) in the direction of the ear that needs more amplification
- up Turn screw 3 clockwise to tune the volume of your own voice do this while wearing the headphones and monitoring the resulting volume of your own voice
- ☐ Turn screw ☐ clockwise to increase the intelligibility of the speaker depending on the surrounding noise
- ☐ Turn screw ☐ to the right to amplify the high frequencies, to the left to amplify the low frequencies
- * The adjustment of own voice amplification is available only while using the HEAR MOON standard headset
- ** When using the ear-ins with the memory effect, roll them into a narrow cylinder. Put the ear-ins into your ear canal. The ear-ins will spread out and mold to the shape of your ear canal after a short time

STEP 4. CONNECTING THE DEVICE TO YOUR SMARTPHONE

STEP 5. USING THE SMARTPHONE APP

The control app allows extending the sound personalization and performing more fine adjustments that are unavailable on the device. The device remembers the current position of the encoder and adjustment screws and synchronizes with the control application. If you change the settings using the application, a user's set of settings will be created and also get synchronized with the device

STEP 6. WEARING THE DEVICE

Fasten the device body to your clothes on your chest using the clip. Place the speakers at a distance (6)

STEP 7. SWITCHING OFF THE DEVICE

Press and hold (>3 sec) button (4) on the device body until you see a red light

STEP 8. CHARGING THE DEVICE

When the battery is discharged, connect the charger to the USB Type-C plug (2) and wait for it to fully charge. When fully charged, all the indicators will be white. Do not use the device while it is charging

WARRANTY TERMS

- 1. The warranty repair of the device is conducted on condition the user has a completed warranty card
- 2. The device that is repairable on a warranty is to be delivered to the technical support service by the user themselves at their own expenses
